- vii) The selected FPC must have to strictly maintain GST norms at their own cost and has to deposit the tax as applicable to the competent local authority. The FPC will be held responsible for any dislocation in statutory compliance.
- viii) **The selected FPC has to collect PAMCL products of Sufal Bangla brand from Ranaghat Hub of Sufal Bangla.
